#### **Objectives and Activities**

- 1. The relief and promotion of those in need by reason of learning disability through the provision of housing, other facilities and services to young people with a learning disability, and their parents and carers.
- 2. The provision of recreational facilities and the organisation of recreational activities with the object of improving the life of young people with a learning disability, and their parents and carers.
- 3. The advancement of education for young people with a learning disability through the provision of facilities and services which will improve the nature of their lives.

#### Review of our Achievement and Performance

Elsie Normington Foundation (ENF) has continued to pursue the vision of developing a specialist integrated centre called the Haven Centre - to serve children and young people with severe learning disabilities and complex needs in the Highlands. This centre will provide a specialist play centre and respite flats to offer social opportunities and overnight social care for these young people.

#### **Achievements and Performance**

- 1. ENF convened Board meetings every six weeks throughout the years. Each Trustee had areas of responsibility to action and report at these meetings.
- 2. ENF employed Rona Matheson as a part time community fundraiser. She has consistently been successful at raising funds through a wide range of social and fundraising events and also been successful at recruiting new volunteers who help at events and also run with their own fundraising ideas. Rona also has done several public speaking engagements and been very successful at raising funds through these occasions.
- 3. ENF employed a Marketing Co-ordinator, Iain Boyd through the Scotgrad Scheme which was managed by Highlands and Islands Enterprise. This was a very successful post, and much was achieved in developing a contemporary marketing approach and rebranding current materials. Although his post finished in January 2020, he has continued to support the Haven Appeal remotely as a Volunteer which has been greatly appreciated.
- 4. ENF also employed a Co-ordinator Martin Baldwin who started his post in February 2020. The purpose of this post was to co-ordinate and improve administration systems for ENF and also apply for Grant Funding Applications for the Haven Appeal.
- 5. Many meetings were convened with Highland Council officials regarding the site development and planning permission was received on 26 March 2020. The Business Plan has been updated to reflect various changes as the project continues to evolve and develop.
- 6. A visit was made to the Scottish Parliament where Elsie Normington, Chairperson gave a short presentation to a cross party group of MSPs regarding the Haven Centre. All MSPs present were most supportive of the project. This was followed up by further meetings at Constituency Offices with various Government Ministers and MSPs.
- 7. ENF was regularly highlighted in the local Inverness Courier and the Foundation is most grateful for this ongoing coverage which has kept public interest in the project.

#### Achievements and Performance (continued)

8. Governance - Sheila Proudfoot, Alistair Dodds and Helen Bull resigned after serving two terms of three years. David Sutherland, Ian Matheson and Jonathan Innes were elected to the Board. Thom Macleod and Bill Dickson were appointed to the Board. David Sutherland was appointed as the Chair of the Haven Appeal. Arlene Johnston from NHS Highland was appointed as NHS Advisor to replace Eilidh McMillan. John Gallon was appointed as Advisor for people with learning disabilities. Liz Sutherland was appointed as Advisor from Smithton Residents Association.

#### Financial Review and Reserves Policy

The charity's principal source of funding through grants, donations and fundraising. There was a surplus for the year of £70,096 (2019: £6,398). At the year-end there were total funds of £276,637 (2019: £206,541) The trustees believe that they will be able to meet expenses as they arise.

# Report of the Independent Examiner for the year ended 31 March 2020

I report on the accounts of the charity for the year ended 31 March 2020 which are set out on pages 5 to 8.

### Respective responsibilities of trustees and examiner
